SHELTER - WE OFFER A CONTINUUM OF SERVICES FOR WOMEN, MEN, AND CHILDREN IN OUR SIX COUNTY SERVICE AREA. OUR PROGRAM SERVICE MIX IS DESIGNED TO ASSIST CLIENTS FROM CRISIS TO STABILITY. WE PROVIDE A CRISIS SHELTER FOR FAMILIES FLEEING THEIR HOMES DUE TO DOMESTIC VIOLENCE. OUR CRISIS SHELTER IS COMPRISED OF STAFF AROUND THE CLOCK ASSISTING CLIENTS WITH IDENTIFYING THEIR NEEDS, CONNECTING TO RESOURCES, AND PLANNING FOR A SAFE FUTURE. 943 CLIENTS WERE ASSISTED THROUGH OUR PROGRAMS AT THE SHELTER. OUR TWENTY FOUR HOUR CRISIS LINE, WHICH HANDLED 6,126 CALLS IN 2014, IS STAFFED WITHIN THE SHELTER PROGRAM.

OUTREACH - AS PART OF THE CONTINUUM, WE OFFER COMMUNITY PROGRAMS TO THOSE THAT MAY NOT NEED SHELTER AT THE PRESENT, YET NEED TO EXPLORE THEIR OPTIONS OF STAYING VERSUS LEAVING, SAFETY PLANNING, EMOTIONAL SUPPORT, AND ONGOING CASE MANAGEMENT. 582 CLIENTS WERE ASSISTED THROUGH COMMUNITY PROGRAMS. CASE MANAGERS IN OUR CONTINUUM NOT ONLY PROVIDE INDIVIDUAL CASE MANAGEMENT YET FACILITATE SUPPORT GROUPS IN OUR SIX COUNTY SERVICE AREA. GROUPS MEET WITHIN OUR SHELTER, MAIN OFFICE, WITHIN JAILS IN NORTHEAST INDIANA, AND A HOMELESS SHELTER/RECOVERY HOME. THESE GROUP SESSIONS HAD 188 PARTICIPANTS IN 2014.
