Through the generous support of our community, our Campaign for Dignity was a success and we were able to embark on a journey that allowed us to renovate and expand our facilities. We moved from breaking ground in March 2016 to completing the first phase of construction in

November! At that point our administrative and outreach services moved to the new facility and the number of beds in the domestic violence crisis shelter increased from 45 to 65, all of which were filled immediately upon the move.

In addition to the construction project in 2016, we also continued to work diligently to serve the Northeast Indiana community through our case management, education, addiction, and refugee services. As you flip through the pages of our annual report, you will see our story told through pictures and statistics. All of these achievements would not have been possible without the generous support of all the individuals and organizations listed on the pages of this report. With your help, YWCA Northeast Indiana brought dignity back into the lives of some of Northeast Indiana's most vulnerable individuals.




