THE HOPE & HARRIET PROGRAM IS ONE OF FEW ADDICTION RECOVERY TREATMENT CENTERS IN INDIANA THAT ACCOMMODATES WOMEN WHO HAVE RETAINED CUSTODY OF THEIR CHILDREN. THIS ENABLES WOMEN TO RECEIVE QUALITY, IN-PATIENT TREATMENT WITHOUT HAVING TO GIVE UP CUSTODY OF THEIR CHILDREN.
