Our domestic violence services reach six northeast Indiana counties: Allen, DeKalb, Huntington, Noble, Wells, and Whitley. In 2024...

Bonnie's House Domestic Violence Shelter

Provided 14,967 shelter beds

- 52% of the clients were adults
- 48% of the clients were children

Community Advocates

One-on-one support with everything from writing financial plans to case management to emotional support for a successful new life.

- Assisted 395 adults in the community
- Created 332 safety plans
- Supported clients with 539 legal issues including escorting them to court or helping to obtain protective orders.
